Currently, countywide workgroups are forming to move the key priorities forward. # 2024-2025 Achievements

#### CyBiz LAB Partnership

Supported by the City of Grinnell, Claude W. and Dolly Ahrens Foundation, Greater Poweshiek Community Foundation, Grinnell College, Grinnell Mutual, and a Power of Connection Grant from ITC Midwest, a comprehensive study of the county's entrepreneurial ecosystem was conducted in partnership with CyBIZ Lab at Iowa State University to examine economic trends, survey residents and businesses, and benchmark comparable rural communities.

#### **Downtown Assessments**

Through support from local organizations, the Iowa Economic Development Authority conducted downtown asssessments for Brooklyn, Grinnell, and Montezuma to report short-and long-range recommendations to support downtown improvements.

#### **Rural Innovation Grants**

Collaborating with Poweshiek Development, Sips Coffee Company in Grinnell and Dayton Meat Products in Malcom secured \$5,000 Rural Innovation Grants to support equipment purchases and specialized research.

#### Strategic Business Plan

In early 2025, Poweshiek Development finalized a Strategic Business Plan designed to guide countywide economic development and move ideas into action. Built from extensive leadership input, community surveys, and a shared vision, the plan reflects a united approach to building Poweshiek County's future.

#### The Strategic Business Plan outlines primary focus areas:

- 1. Maintain a focus on county-wide job growth and retention.
- 2. Design a comprehensive business outreach effort that focuses on entrepreneurial start-ups, small businesses, and primary sector employers.
- 3. Lead a county-wide effort to identify, analyze, secure, and develop new industrial and commercial sites.
- 4. Lead a branding, promotion, and marketing effort.
- 5. Work with local partners to form a workforce and housing needs analysis team.
- 6. Focus on putting programs and strategies in place for the sustainability of the organization.
